Minutes of the Annual General Meeting 19th March 2021

The meeting commenced at 7.30 pm.

1. Acknowledgement of Country

The President, Peter Gray, opened the Meeting, and acknowledged the traditional owners of this area, the Gundungurra people, past, present and future. Before the Meeting started, the President called on the BCA Poet Laureate, Bronwyn Beard, to open with a performance poem, which took the form of a sea shanty.

2. Welcome to members and visitors

The President extended a warm welcome to members and visitors. He explained that this Meeting was covering two Annual General Meetings, since the one scheduled to be held in March 2020 had had to be cancelled because of Covid restrictions. This was done on the advice of the NSW Department of Fair Trading.

3. Attendance and Apologies

Attendance: 39 Members, 5 Apologies, and 1 Visitor Apologies were received from Angus Taylor MP, Mrs Wendy Tuckerman MP, Clr Peter Nelson, Clr Ian Scandrett, Clr Larry Whipper, Vera and Gordon Blain, Ian Booth

4. Confirmation of the Minutes of the 85th AGM held on 15th March 2019.

Christine Janssen pointed out that the statement Winterfest was not held in 2019 as the Minutes record was incorrect,

but the year it was not held was 2018, and that her name was missing from the list of Apologies.

Moved Elizabeth Cranny, and seconded by Joy Brown, that the 2019 AGM Minutes, as tabled and with the above omissions corrected, be confirmed. <u>Carried</u>.

5. There was no **Business Arising** from the Minutes.

6. Proposed constitutional amendments

These amendments had been fully discussed by the Committee.

a) Special resolution Number One: "Remove the requirement for ordinary members to be over the age of eighteen."

Moved Andy Carnahan, seconded Jeremy Tonks; the Committee recommended this resolution be adopted. <u>Carried</u>.

New wordings in the BCA Constitution:

The words "and they are over the age of eighteen (18)" are to be deleted from the last sentence of Section 2.1 Eligibility, 2.2.1 Membership of the BCA, and a new section 3.14.5 is added **Members under 18 years of age** as below, and new section 3.13.2 **Members under 18 years of age** is to be added to 3.13 Delegation by Committee to Subcommittees as follows:

2.2.1 Membership of BCA

Membership shall be open to:

- (a.) all residents of Bundanoon NSW, and
- (b.) all owners of property in Bundanoon NSW, and
- (c.) all owners/operators of businesses in Bundanoon NSW, and
- (d.) people with a particular interest in or a connection

with Bundanoon through their involvement in the community, provided (1) they complete a membership form and pay any and all initial and recurring fees as decided by BCA, and (2) their membership has not been suspended or cancelled.

3.14 Voting and Decisions

3.14.5 Members under 18 years of age

A member is not entitled to vote at any general meeting of the association if the member is under 18 years of age.

3.13 Delegation by Committee to Subcommittee

3.13.2 Members under 18 years of age

This delegation excludes any Subcommittee member under 18 years of age.

b) Special resolution Number Two: "Add new section to clarify the Not-For-Profit basis of the BCA."

Moved Andy Carnahan, seconded Elizabeth Cranny; the Committee recommended that this resolution be adopted. <u>Carried</u>.

New wording: a new section 5.2 ASSOCIATION IS NON-PROFIT is added to Section 5 MISCELLANEOUS as follows:

5.2 ASSOCIATION IS NON-PROFIT

Subject to the Act and the Regulation, the BCA will apply its funds and assets solely in pursuance of the objects of the association and must not conduct its affairs so as to provide a pecuniary gain for any of its members. c) Special resolution Number Three: "Add new section to clarify membership of Subcommittees requires general membership of the BCA."

Moved Andy Carnahan, seconded Christine Janssen; the Committee recommended that this resolution be adopted. <u>Carried</u>.

New wording: a new section 2.1.7 under Membership is added as follows:

2.1.7 Membership of Subcommittees

Where the BCA has Subcommittees, whether an organising group, an activity group, or any other group, regular members of those Subcommittees must be members of the BCA.

Moved Andy Carnahan, seconded JW; the Committee recommended that this resolution be adopted. <u>Carried</u>.

- 7. President's 2019-20 and 2020-21 Reports were presented by Peter Gray, who spoke to his two Annual Reports (printed in full in the two AGM Booklets tabled). Christine Rowell-Miller moved, and Tony Strong seconded, that the Reports be received. <u>Carried</u>, with acclamation.
- 8. Consideration and Adoption of Financial Statements The Financial Statements, prepared by Laterals GLP Chartered Accountants of Goulburn, contained in the AGM booklet which had been tabled, were presented by the Treasurer, Peter Brown.

The Treasurer first thanked a number of people who had assisted his work by keeping figures for various Subcommittees: Cherie Hobart for *JCG* and Winterfest;

Sue Fraser for Garden Ramble; Lorraine Dillon for Hall bookings; and Sue Roseworne for Melting Pot Theatre.

 a) With regard to the Financial Statements for 2019: The Treasurer highlighted the main figures, including expenditure, and surplus capital equipment.

Stuart Reid moved and Andy Carnahan seconded, that the Treasurer's Report for 2019, as tabled, be accepted. <u>Carried</u>.

b) With regard to the Financial Statements for 2020 The Treasurer remarked that it had been a difficult year, but the result was remarkable in the circumstances, with a loss of only \$16,718. The valuable grant of \$37,000 secured by James Fulford-Talbort for Winterfest was treated not as revenue but as pre-payment for Winterfest activities. Under capital expenditure, there was \$2,200 for a laptop computer for JCG, and \$20,636 for the stage lighting, and \$3,075 for the AED.

Questions: Andy Carnahan asked about the increase in risk insurance, which the Treasurer explained. Christine Janssen clarified that the JCG computer cost only \$1,316.

Peter Brown thanked the Committee for their full support, and Laterals for their continued help.

As he was not standing for re-election, a vote of thanks to Peter was carried with acclamation.

Rachel Russell moved and Rosemary Page seconded, that the Treasurer's Report for 2020, as tabled, be accepted. <u>Carried</u>.

9. Consideration and Adoption of **Auditor's Report** The Auditor's Report, prepared by Laterals GLP Chartered Accountants of Goulburn, contained in the AGM booklet which had been tabled, was presented by the Treasurer, Peter Brown.

There were no questions or discussion.

Christine Rowell-Miller moved and Greg Olsen seconded, that the Auditor's Reports for 2019 and 2020, as tabled, be accepted. <u>Carried</u>.

10. Consideration and Adoption of Subcommittee Annual Reports

These were contained in the AGM booklet which had been tabled.

Rachel Russell moved and Rosemary Page seconded, that the 2019-20 Subcommittee Annual Reports, as tabled, be adopted. <u>Carried</u>.

11. Election of BCA Officers and Committee for 2020-21

The President declared all positions vacant, and called on Mr Grant Pearce from Laterals GLP to conduct the elections.

Mr Pearce declared that the following nominations had been received for the various positions:

President – Andy Carnahan Vice President – nil Treasurer – Gregory John Olsen Secretary – Bruce Marshall Committee members – Ralph Clark Mel Morris Stuart Reid Jeremy Tonks Leeanne Tyler-Olsen

Mr Pearce advised that, as there were 8 nominees for 8 of the 9 positions, he declared all those nominees duly elected, and invited them to take a seat at the front of the Hall. Following the declaration, the incoming President, Andy Carnahan, took over the role of chairing the Meeting. He thanked those who had volunteered for executive positions and Committee membership, and spoke in particular of the new Treasurer's skills. The Committee would consider the position of Vice President which had not been filled and seek to co-opt a suitable candidate.

12. Confirmation of **Sub-Committee Convenors for 2020-21** The newly elected President thanked the Convenors for the work done during the past year.

13. Appointment of Auditor

Peter Brown moved, and Henk Janssen seconded that Grant Pearce of Laterals GLP Chartered Accountants be appointed as the Association's Auditor for 2021-2022. <u>Carried</u>.

14. Appointment of Public Officer

Christine Rowell-Miller, having indicated her willingness to continue, was confirmed as the Public Officer. Christine also agreed to continue as the BCA Representative on the Southern Villages Group.

There being no further business, the Meeting closed at 8.15 pm

President's Report

Although 2021 will be remembered for Delta and Omicron, your BCA has continued to do the "good things" which the Association is known for.

I attempted, with mixed success to try and bring greater interest to the General Meetings by preparing Agendas with reports and items distributed via our newsletter prior to the meetings. I have also aimed to reduce paper by using the data projector to project somewhat blurry copies of business papers on the screen. I also appreciate the sound is not always perfect and we are working through that.

My idea was that at meetings if the reports had been pre-read, then only questions arising need take up the meeting. I would rather the meetings were less reporting and more engaging, hence General Business contains items of business for the current meeting rather running through reports and then asking if there are items of business. Initially this may have been overmanaged from the Chair. However, I always prefer meetings where an Agenda is clear, and the meeting can run to a timeline. I think 60 minutes is enough time for people to sit at any meeting.

The Committee agreed to include a guest speaker. Due to Covid, we only managed one in 2021 and that was Angela Williamson, both a BCA member and a member of ABC Friends Southern Highlands. In February 2022 we enjoyed Claire Hewat speak about the success of the Robertson Women's Shed. I hope members agree guest speakers are a refreshing addition to General Meetings.

Covid-19 with its Delta and Omicron variants disrupted many activities. By the last easing of the restrictions, we were up to version 16 of our Covid Safety Plan. For now, the Hall is restriction free, and I hope we can all resume our activities with safety.

We held no General Meetings in July or August and held informal Zoom General Meetings in September and October.

The Committee continued to meet in person or via Zoom to continue the day-to-day activities of the BCA.

The biggest disappointments were the cancellation of Winterfest and the Garden Ramble. The Committee was aware of the heartbreaking amount of work involved in getting Winterfest almost to the point of delivery and then having to cancel it a week out. Thanks to the Winterfest subcommittee and their huge effort in continuing in the face of uncertainty. Winterfest 2022, we hope will reward and delight the subcommittee, the BCA and the village.

The Garden Ramble was cancelled in July because of the anticipated ongoing Covid risks in October. This was proved correct with Delta ruining events across the country. The Garden Ramble 2022 is shaping up well with gardens already confirmed. Many thanks to Sandy Weir who has steered a number of Garden Rambles and has been convenor for the past two years. Sandy has smoothly passed the convenor role to Robin Coombes.

Two subcommittees have been retired and three new subcommittees have been created.

ComCom and the *Bundanoon Pool* (*Swim All Year*) committees were retired. Thanks to Jess Raschke and Lyndell Giuliano for the work with ComCom and Henk Janssen for the Bundanoon Pool Committee.

Bundanoon – As Plastic Free As We Can Be began to encourage the uptake of truly compostable single-use items and to reduce the soon-to-be banned single use plastic in shops. Peter Gray suggested and is the convenor of the *Technical Assets* subcommittee which is responsible for the lights and sound in the Hall. The *Planning and Development* subcommittee with Harvey Grennan as convenor "re-emerged" due to a number of developments that, while they may be needed, dismayed many members with their execution.

As part of a vibrant Association, Subcommittees will come and also retire. If a member has an idea for a Subcommittee, with the expectation that they are also prepared to convene (!), the Committee is always open to proposals. There have been some changes during 2021 to Subcommittee Convenors and these are shown in the list of Convenors above. Many thanks to the outgoing Convenors and best wishes to the incoming Convenors.

The Subcommittees form the visible part of the Association. Some are visible by their activity, others by their action. Melting Pot Theatre, Arts Bundanoon (Music at Ten), Rex Cinema, Bundanoon Sings!, the Bundanoon Ukesters, Bundanoon Pipes and Drums and Needles and Natter are visible and all are welcoming of new, or just curious visitors. The Garden Ramble, Winterfest, JCG Magazine, the Green Team, the bushcare teams of Leaver Park, De Meyrick Reserve and Glow Worm Glen Track, Bundanoon on Tap, the Hall Willing Workers, the Hall Booking Officer, Technical Assets, Planning and Development, Plastic Free As We Can Be, the Membership Secretary, the BCA Website and 'Welcome to Bundanoon' are all visible by what they do, even though it may not be apparent who is doing it.

The Committee too is largely unseen but acts on behalf of the members, our charter and the interests of the village.

Thanks to the Committee, and to those who have assisted, we now have:

• A collection of flags for flying at the Southern Villages War Memorial using the advice of the National Protocols Office for events of significance. This includes the Australian, Aboriginal, Torres Strait Islander and United Nations Flags. You may see the Australian flag flying at half-mast when a NSW State Funeral is held.

- An AED (Automatic External Defibrillator) trainer and CPR manikin. We successfully applied for a grant for a second AED and that is installed in the external vestibule of the Bundanoon Hotel, complementing the AED in the external vestibule of the Memorial Hall. Both sides of the "tracks" now have AEDs. The AED trainer and CPR manikin allow us to undertake bystander response exposure to sudden cardiac arrests. We have held a number of sessions with extraordinarily positive feedback. I encourage all members to try CPR on a manikin to build a community "herd immunity" in the case of a sudden cardiac arrest.
- An approved grant to fence the off-leash dog park in Jordan's Crossing Reserve. This has some way to go, including community consultation, but an idea put forward by a BCA Committee member was promoted by Council for a Federal Grant for Bushfire Resilience. Dog owners know the mental health benefits of their four-legged friends and those who have visited the Moss Vale Off-Leash park know how well a fenced park works.
- Council recognising the need for footpaths. The Committee submitted a project to complete the popular walking loop from the Bundanoon Hotel, past the Bundanoon Club, though Jordan's Crossing Reserve, and also to pave from the entrance of Warrigal to the Hotel. Both were costed. The path from Warrigal has the added benefit of providing a safe path to the village shops without having to cross the pedestrian unfriendly railway bridge. The Committee also provided feedback to Council that their three-year projected budget contained zero dollars for new paths across the entire

Shire. We were hopefully not the only ones to notice this, but we were glad to see an adjustment was proposed to move a significant sum of money to new footpaths.

 One outstanding item is to provide a safe access to the Hall audio-visual loft. The vertical ladder is not suitable, and we have been working through designs, have a design accepted by the Committee and the General Meeting and will be working to submit a grant application in August 2022. We are also seeking to replace the projector screen on the stage which is heavy and not 'failsafe' and also the functioning but not sharp enough data projector.

The slow re-opening of Glow Worm Glen continues to be of concern to the Committee and we are sure many members. I have made several representations asking for progress updates and emphasising the connection Bundanoon feels for their Glen. The National Parks and Wildlife Service are well aware of our position; however, they have a huge backlog of repairs following the 2019/2020 fires.

Our financial position remains strong, and the Committee believe we have invested members' funds judiciously. Our balance sheet has reduced by some \$20,000 in 2021 but we have an upgraded sound system in the Hall and kilts for our Pipe Band, amongst other items to show for it.

2021 also graced many of us with the inspiring BCA wildlife calendar. Notwithstanding that many events on the calendar could not occur, the beautiful illustrations graced many homes. Thanks to Lyndell Giuliano and Sonja Bowden the calendar and auction netted the BCA around \$7,000. To continue the images, the Committee also printed a number of high-quality gift/note cards and these are for sale, along with the Bundanoon on Tap bottles on the BCA website shop.

I am proposing to stand for President again in 2022. I am inspired reading two decades of back issues of the JCG seeing the many great achievements of the BCA, its committee and members, most of which are now taken for granted by those who are unaware of the toil to get those achievements.

It is better to achieve big things quietly than small things loudly.

Bundanoon – Plastic Free As We Can Be

The Bundanoon – Plastic Free As We Can Be Subcommittee (B-PFAWCBS) has been active since July 1, 2021. Its members are Gregory John Olsen (Convenor), Anni Baillieu, Trevor Wright, Lee-anne Tyler-Olsen, and Christine Rowell-Miller.



Our first task was to survey 24 Bundanoon shops front businesses to assess how much single-use plastic they employ and how willing they are to replace it with home compostable alternatives. We had a 100% positive response from those surveyed, who are all keen to reduce single-use plastic.

We undertook research to find products that can replace single-use plastic and offered that info to the businesses.

Leeanne has written articles for the Jordans' Crossing Gazette, describing the aims, objectives and progress of the B-PFAWCBS. Our logo has received great support and places Bundanoon ahead of the game in the Shire. It will soon be on display on Bundanoon Rd, near the information bay.

We are very excited to announce that, in partnership with the Wingecarribee Shire Council and Boomerang Alliance, we will be participating in the Plastic Free Places initiative: <u>https://www.plasticfreeplaces.org/</u>, commencing on March 21.

Plastic Free Places is a free scheme that aims to help participating businesses in their transition away from singleuse plastic packaging and items, a reality that will soon become law in NSW. Bundanoon/Exeter/Penrose have been chosen for the pilot scheme which, if successful, will be rolled out across the Shire. This is a result of the efforts of B-PFAWCBS.

Bundanoon - Plastic Free As We Can Be continues to build on the highly successful Bundanoon On Tap campaign started in 2009.

Bundanoon Soldiers' Memorial Hall

Covid has again caused disruptions throughout the year, with many activities cancelled from August onwards. However, by February this year most of our regulars are using the Hall again, under eased Covid restrictions.



In June our new doors were manufactured and installed, and funded by the Council. In July our two new electric/gas stoves were installed. Council not only paid for the stoves but also the installation costs. We were hoping by now to have catered functions by both local organisations and individuals, and outside groups, but unfortunately this has not eventuated. Our first booking using the new equipment will be the Ceilidh for Brigadoon in early April.

Unfortunately, the new roof promised by the Council's Interim Administrator, Mr Viv May, didn't eventuate this financial year. After three years as Hall Convenor, I am also standing down. However, we have a replacement in the wings.

Once again, my heartfelt thanks to all our Hall Willing Workers for their commitment in keeping the Hall clean and sanitised during this difficult year, with willingness and good humour.

Technical Assets

The Subcommittee is returning from a quiet period resulting from the Covid restrictions in force for most of last year. Life is starting to return to normal as more groups utilise the Hall's facilities.

The 'Green Circuit' project was installed to improve the operation of frequently used items. Members can now operate the stage mics – LH & RH, wireless hand held mics, the lectern and its mics, and the CD player from a single area in the left hand wings of the stage. It reduces the number of journeys to the Loft necessary to turn on/off the mixing desk and amplifier. When the green circuit is switched on, it powers-up all the items listed above. On completion of activities the same single

switch turns them all off. A recent addition is a 3.5mm TRS connector to provide a connection for additional inputs, such as music stored on iPhones, and other stored music devices.

The current project involves locating mics on stage to amplify stage activities, providing improved sound to patrons seated at the rear of the Hall. To expand the flexibility of this addition, a multi-channel mixing desk is to be installed next to the Green Circuit. This will allow different inputs to be used and provide the ability to carryout local audio control. Funding for this project has been provided by a grant from Wingecarribee Shire Council through its Community Assistance scheme.

A users guide has been written for operation of the ChamSys QuickQ 10 Lighting Console in the Hall Loft, with specific reference to this Hall. Training sessions which should have been completed by now will be organized as soon as possible.

Over the Christmas break we have had something of a hiatus with the band resuming weekly practice in February at the hall.

This year we have welcomed a new snare drummer bringing our current contingent to 5 pipers, 2 tenor drummers, a bass drummer and 3 snare drummers. We are still too small to be considered an official pipe band for Brigadoon or other purposes but this remains a goal of the band. In the meantime we are open to invitations to play at local events of significance.

Representatives from Council and other community linked groups, such as the Rural Fire Service, are invited to the meetings to discuss specific areas of concern or interest which SVG seek discussion and increased understanding about.

Treasurers' Report

The financial position of the Association remains strong despite the impacts of COVID-19.

The calendar year 2021 ended with total equity of \$207,237 an increase of \$1,596 compared with 2020.

There was a considerable loss of revenue, largely due to the fact that our major fundraising activity, the Garden Ramble, did not occur.

We completed the Hall Sound Upgrade which cost \$7,470, and also provided kilts and components for the Bundanoon Pipes and Drums for \$2,120.

On the positive side, the Treasurer has realised a cost saving of \$1,200 by changing the Hall's gas and electricity suppliers.

The BCA's December 30, 2021 cash balance of \$127,758 is down by \$40,526 compared with 2020.

Given the lack of income and the impact of Covid-19, this is a reasonable result.

The aim of the BCA should not necessarily be a high balance sheet, rather a good financial reserve, and the spending of our funds to provide community engagement and activities that support the aims of the Association.

I am looking forward to a brighter 2022 when the full community activity of the BCA, through its Subcommittees, returns to normal.

Notes to the Financial Statements

Bundanoon Community Association Incorporated For the year ended 31 December 2021

1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act of New South Wales 2009. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Property, Plant & Equipment

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required tosettle the obligation at the end of the reporting period.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in theassets and liabilities statement.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.
