Business Arising from the Minutes

President and Treasurer began preliminary discussions with Men's Shed and Highland Gathering over new lease for storage. Road being de-gazetted to community land and BCA to get space.

President informed Southern Highlands Post and Tourism Southern Highlands there will not be a Winterfest event for 2017.

Presentation

Bundanoon Club Director and Advisory Group Member, and former BCA President and Secretary, Peter Ellsmore, brought BCA members up to date with Club developments and suggested the possibility of a closer association with the BCA.

Advisory committee options

- 2. Community hub unlicensed, gaming machines gone.

Dear Mr Duncan

Thank you for your letter of 18 April 2017 regarding Bundanoon Water Supply.

Please find below responses to the matters raised, noting I have kept the same numbering for ease of reference.

1 Council's minimum supply standard stipulates a minimum static pressure of 12m head (120kPa) at the water meter and an instantaneous demand of 0.10 L/s/tenement (or 0.15L/s/tenement when serving less than 1000 tenements).

- 2. A water supply master plan was completed in 2015 using Councils water supply model. The master plan analysis included flow and pressure assessment for the entire Wingecarribee Shire Council water network. An extract from the master plan identified the following for the Bundanoon & Exeter systems:

The existing system under current demands meets all required standards of service:

- The system meets the 12m minimum pressure for customers with a small number of exceptions. Customer's located in close proximity to Exeter & Bundanoon reservoir's resulted in low pressure that cannot be resolved with the existing infrastructure
- The system meets the 24 hours peak day demand (PDD) total reservoir storage standards of service target (SoS) for both the Exeter and Bundanoon reservoirs and their associated zones

- The system also meets the desirable 12 hours minimum reservoir storage at the lowest normal operating level for both reservoirs.
- No major capital works in Bundanoon have been identified as being required to service the current PDD or PDD out to 2031.

Further to the above master plan, development impact assessments are carried out on a case by case basis at time of or before DA lodgement.

 Infoworks WS (Pro) supplied by Innovyze is used by Council's engineer and consultants for hydraulic modelling of the water supply system. Infoworks WS is an industry leading software package for water modelling.

- Water and Sewer Modelling is undertaken by both internal staff and consultants where required.
- Council's water model is calibrated based on reservoir controls, pump stations, actual customer consumption and elevation. A detailed model calibration is scheduled for completion by June 2017

Following the detailed calibration, Council will investigate the use of its SCADA system as a direct data feed into the model. Making it a live calibrated model.

- The model is updated on an annual basis with new pipe work, property information and customer demand included.
- 7 A water supply master plan was completed in 2015. This master plan projected future population growth across the shire and identified pinch points in the water system. Capital works upgrades were recommended based on Council's minimum standard for water supply to ensure continual supply now and into the future.

Those upgrades are included in Councils capital works program for implementation in the coming years, with some significant projects already underway including:

- Duplication main between Bowral and Moss Vale to boost supply from Wingecarribee WTP to the southern towns (Moss Vale, Sutton Forest, Exeter & Bundanoon)
- Water pump station upgrade at Oldbury Rd Sutton Forest, to enable transfer of water from the Moss Vale system to Exeter & Bundanoon.
- Water pump station upgrade at Werai to improve the flows into the Exeter & Bundanoon system from the Bundanoon water treatment plant.
- Process improvements at the Bundanoon raw water dam and treatment plant.
- 8. The Bundanoon zone is predominantly fed by the Exeter Reservoir (4.5ML storage) via two inlet mains (Bundanoon Rd, and Ellsmore Rd). The Bundanoon zone consists of two reservoirs (3.86ML total storage) which act as additional storage during peak demand.

Over the summer months Council received a number of complaints relating to poor pressure from customers within the Bundanoon zone. Investigation was carried out which included pressure logging and rezoning. Pressure improvements were evident as a result of rezoning. Further to this Council is undertaking additional water modelling to determine options to improve the average zone pressure within the Bundanoon catchment.

It is my intention to meet with representatives of your Association with relevant staff in the coming months.
