- 6. General Business
- a) **Business arising** from the previous meeting minutes and correspondence (if any)
 - a. Treasurer's report An item in the balance sheet showing a \$10,000 loss with "internal transfer" was an internal transfer between two BCA accounts. At the time the balance sheet was run, the reconciliation only reflected one side of the transfer. The August trial balance shows the account (BDCU Online Saver) now has the \$10,000 reflected \$38,220.17 in July, \$48,472,05 in August.
 - **b. Disposal of equipment** the piano has found a new home in Bundanoon. One table tennis table has found a new one. One needs a home.
 - **c. Rear to kerb parking** a letter was sent to Council asking to add more rearto-kerb parking signs at the curve of Church Street and Railway Avenue.
- b) **Ellsmore Road Footpath** the loop walking track has now been completed thanks to Council's footpath program. It makes access to the Preschool and Quest much safer. (see attachments showing the footpath sections)

- d) 48 Old Wingello Road stage two this DA went to the Wingecarribee Planning Panel and was deferred. The BCA presented arguing that the front open space should not have six units over the footprint of the first DA. While this is allowed, the Panel did not support the front section to be for residential purposes unless the applicant could produce drawings showing these were part of a site masterplan. President's Report 15th September 2022

Although reported in General Business, I was very happy to see the two sections of footpath laid on Ellsmore Road in late August and early September. Good footpaths are important for social fabric.

The development on Old Wingello Road has had its second DA deferred, although with modifications it will continue. I attended and spoke at the Local Planning Panel where Council had recommended refusal of the second stage. The Panel did not agree but had some clarifications required and several conditions required. Pleasingly for the Village, four of the six additional dwellings proposed for the front will most likely be refused. These would have presented Old Wingello Road as the back fence of four units with a very narrow street frontage.

The Bundanoon Ukesters, of which I am a part of, held our annual concert on Saturday 10th September. We are a wonderful group, and to me, reflect a lot of what the BCA aspires to.

Congratulations to the members of the group who came to the front to sing, harmonise, harmonica-ise and to those who came onto the stage to play. We are inclusive and welcoming to everyone who wants to come and learn ukulele and sing together. Our audience was appreciative, and we all sang loudly together. It was a night of joy.
