# President's Report 21 December 2023

While investigating the lease of Picnic Park by looking back over the records of the forerunner to the BCA, the Bundanoon Community Development Association (BDCA) many issues in their meetings are by and large the issues still under discussion.

The railway pedestrian crossing, the overbridges, presentation of the village, development, safer footpaths, supporting our retailers, improvements to the Hall, not closing the Pool. 25 years later progress in some areas, not much in others.

Complex multi-agency, high-cost changes will always be difficult, and it is easy to lose hope. For example, the rail overbridge involves ARTC (Federal) who own the track and rail corridor, Transport for NSW (State) who own the bridge and deck, Council (local) who own the approach roads and their various subcontractors.

Jason Fox, one of Australia's "thought leaders" talks about game theory and applying it to life. Game theory is what makes a game successful – it must not be too hard nor too easy and it needs to provide a sense of meaningful achievement.

The most rewarding activities for the volunteers of the BCA are those that give a sense of meaningful achievement. Some are very visible and appreciated from afar, others are internal and structural and only appreciated by those actually involved.

The Project for Public Spaces, whose Place Game we use, has great advice for positive changes to spaces – go for lighter, quicker, cheaper. As a community group based on volunteers, lighter, quicker, cheaper is, in my view, the best model for activity.

# **COMMITTEE UPDATE – December 2023**

The Committee met on 7 December. Below are items provided for information or comment that were discussed or decided that are not in the business for this general meeting. If you have any questions or would like clarification, please raise this at the end of general business.

ARTC lease on Picnic Park and opposite Bundanoon Hotel – Committee is seeking advice form ARTC in the first instance for a licence renewal that limits the BCA liability to our activities to beautify and enhance the area.

Sponsorship for major events - the Committee endorsed a proposal that the 2024 Ceilidh and 2024 Folk Festival are given the Hall at no cost as a sponsorship 'in kind'.

Funding for Bundanoon Pipe Band – the Committee endorsed a request from the Pipe Band for the purchase of three drums for \$950.

Resilience Expo report - excellent attendance of exhibitors and visitors. Estimate 250 to 350. All stalls well received, those with 'give-aways' especially so. Go-Bag well received. CPR lifesaver challenge and snake bandage wrapping popular. Over 100 questionnaires received to be analysed.

Community Christmas party at the Recreational Precinct report – the weather was an issue and attendance low. Was very well received by those who attended – very satisfying to see community members in demographics the BCA does not reach except via JCG. Funding from Council was used to provide donations to Bowling Club, Tennis Club and Croquet Club. Surplus monies will be suggested for use for a Pool open day in January.
